Why Small Business???

- 99.7% of all employer firms
- Employ 50%+ private sector employees
- Represent 44% of private payroll
- Create > 40% non farm GDP
- Account for 68% net new jobs

So What is a Small Business?

- SBA Definitions are by NAICS, but in general terms:
 - Manufacturers 500 or less employees
 - Wholesale/Distribution 100 or less employees
 - Retail/Service \$6.5 mm or less in sales
 - General/Heavy Construction \$31mm sales
 - Special Trades Construction \$13mm Sales
 - Ag Industry 0.75mm Sales

More Common Definitions

- Small Businesses are 100 or less employees
- Micro Businesses are 1 5 Employees

Government Contracting Essentials

It is the policy of the United States, as stated in the Small Business Act, that "ALL" small businesses have the maximum practicable opportunity to participate in providing goods/services to the government.

Procurement Technical Assistance Centers (PTAC)

- Grant funded
 - state and federal governments
- centers throughout the country
 - 12 centers in Illinois
 - 90 nationally
- Assist businesses in selling to the state, local or federal governments and subcontracting
 - Supply the "how to do business...." information –
 varies based on local vs. state vs. federal
 - Educate you on the various supplier diversity aspects –
 corporate as a prime contractor to government

PTAC

- Customized Computerized Bid Matching
 - Keywords to describe your product/service
 - System searches 400 sites per day
 - Automatic email
- Supply vendor registration information
 - Local city, county
 - State varies by state
 - Federal CCR and ORCA

PTAC

- Assist in proposal creation
 - Explain a government solicitation
 - Assist in assessment
 - Capability to handle the entire contract
 - Teaming relationships
 - Joint Ventures
 - Bullet point the focus
 - Assistance with GSA Schedules contract award
 - Work one-on-one
- Certification assistance identification and assessment
 - Assessment of business vs. opportunities

PTAC

- Market research target market
 - Identify which agency and point of contact
 - Identify the prime contractor and point of contact
 - Relationships are key to expanding your business (helps with teaming and joint venture)
 - Commercial
 - Government
 - Associations: Industry specific
- FREE (majority of states)

Registrations

Two steps that are mandated for federal

- 1) DUNS unique 9 character number provided by Dun & Bradstreet. This is a FREE number. Call 1-866-705-5711
 - 2) Central Contractor Registration (CCR) all businesses must be registered in this central databank. Information used for electronic acquisition documents payment through EFT procedures.
